**2025 Fair Vendor Application for Crafters / Artisans**

1. All Spaces are outdoor only. Spaces are approximately 12 x 12.
2. Early Bird Special: Send in application and payment before June 1, 2025 (postmarked) and get a discount.
3. Each vendor must check in with the Vendor Manager to be shown your assigned space.
4. Due to the size of the fair, we try not to have an abundance of the same products. You may be asked to remove items at the discretion of our Fair Board if you are selling items that are not listed in your application and approved that we think are in abundance or we deem inappropriate. The Fair Board has the right to decline any exhibit, display, or activity that is not suitable.
5. VENDORS MAY NOT SELL ANY OF THE FOLLOWING ITEMS: GUNS, KNIVES, SWORDS, WEAPONS OF ANY KIND, DRUG PARAPHERNALIA, SILLY STRING, SMOKE/STINK BOMBS, LASER POINTERS, FIRECRACKERS, OR SNAP CAPS OF ANY KIND.
6. The Fair Board has the right to decline any exhibit, display, or activity that is not suitable.
7. No raffles or drawings are allowed, unless preapproved by the Fair Board.
8. No vendor's activities may interfere with the display or activities of any other vendor.
9. Vendors to supply their own tent, tables and chairs. and cannot break down their booth early.
10. Every vendor space shall be kept clean and free of trash. Every vendor is responsible for disposing of their trash in the provided receptacles / dumpster.
11. \$45 service fee will be charged for any returned/bounced checks. The Funds owed and the \$45 service fee will then be due in cash.
12. If you need to cancel, we will gladly send you a donation receipt for your donation to the fair.
